Rental Assistance Program

We may be able to help you with your rent depending on the following:

- A. The availability of funds (we do not always have funds available)
- B. Meeting program criteria
- C. Verification of the following documents

Clients need to bring **copies** of the following documents:

- Completed Application
- Identification such as Driver's License or State ID for all adults living with you
- Birth certificate OR Social Security cards for all children under 18 living with you
- Lease with your name and current address (Rental Agreement)
- Last three months of rental receipts
- Eviction notice (if applicable)
- Proof of earned income (Employment paystubs)
- Proof of benefit (Food stamps, SSA, SSI, CalWORKs, Child support disability etc.)
- Last 3-months bank statements
- Proof of emergency- provide expenses any unusual bill or situation that caused you to fall behind in rent (i.e. Medical, etc.)
- Proof that, if helped, you will be able to pay your rent the following months

Note: Once the paperwork is submitted, a preliminary review will be made to clarify any immediate questions. Then an application for Rental Assistance will be completed and forward for evaluation. Once the case is being considered for funding, further documentation may be required to clarify and confirm need of presented situation.

Programa De Ayuda Monetaria para el Alquiler

Hay posibilidad que podamos ayudarle con su pago de alquiler dependiendo de lo siguiente:

- A. Disponibilidad de fondos (no siempre hay fondos disponibles)
- B. Cumplir con los criterios del programa
- C. Verificaciones de los siguientes documentos:

Clientes necesitan traer **copias** de los siguientes documentos:

- Aplicación
- Identificación como la licencia de conducir O tarjeta de identificación del estado para adultos que vivan con usted
- Acta de nacimiento O tarjeta de seguro social para niños menores de 18 años que vivan con usted
- Contrato de arrendamiento con su nombre y dirección actual (Contrato de alquiler)
- Últimos tres meses de recibos de alquiler
- Aviso de Desalojo (si es aplicable)
- Comprobante de ingresos (talones de pago O carta del empleador)
- Comprobante de beneficios (Carta de estampillas de comida, Seguro social, SSI, Cal Works, pago de discapacidad, etc.)
- Estados de cuenta bancaria de los últimos 3 meses.
- Prueba de emergencia- proporcionar facturas y gastos inusuales O situación inusual (por ejemplo: Médicos)
- Si recibe ayuda tendrá que demostrar que si podrá pagar el alquiler del mes siguiente
